# 2021 HAWAII MATHCOUNTS COMPETITION

The virtual 2021 MATHCOUNTS Chapter Invitational Competition was held on February 25, 2021, starting at 2:00 pm HST on the Art of Problem Solving (AoPS) Contest Platform. All competitors throughout the country were required to take this competition at the same time. The Chapter Invitational is an added competition to determine who will compete in the 2021 State Competition on March 25, 2021, at 1:00 pm HST on the same AoPS Contest Platform.

The COVID-19 pandemic did not stop MATHCOUNTS. In-person competition became virtual. Preparations for 2021 competition began in 2020 with registrations beginning on June 16, 2020, followed by four Practice Competitions on the AoPS Contest Platform to get competitors familiar before the Chapter, Chapter Invitational and State Competitions. Most students compete as part of a registered school, however, if a student's school is not participating, the student can register as a non-school competitor (NSC) paying a slightly higher registration fee. Registration started earlier with more reminders since COVID-19 created much reluctance to compete virtually instead of in-person.

# THE ART OF PROBLEM SOLVING CONTEST PLATFORM

AoPS is hosting these competitions online as a courtesy to community and friends at MATHCOUNTS. AoPS staff are not involved in the development of content for any of the competitions. All official competitions are received by AoPS staff at most 10 days before the competition start date and securely handled by only essential contest administration staff.

The AoPS Contest Platform supports recent

versions of web browsers, such as Microsoft Edge and operating systems such as Windows, Mac OS, Android, etc. The Contest Platform can be used on desktops, laptops, tablets, etc. They recommend competitors participate in at least two of the online Practice Competitions to verify their device and system are sufficient for the Contest Platform.

#### **PROCTORING**

All students all over the country take the competition virtually at the same time. These competitors are proctored by coaches or an adult, and they can identify their own proctor or request assistance with one. Proctoring can be done both in-person or virtually.

MATHCOUNTS provided guidelines to the competitors, coaches and parents for proctoring the State Competition. They include the following:

- (1) If possible, proctors should be a nonrelated adult who the competitor's family knows and is comfortable with,
- (2) If possible, proctoring should be conducted in a safe, in-person environment with both the non-related proctor and with a parent or

another adult (other than the proctor) always present,

- (3) Competitors will be required to provide their proctor's information (name, relation, contact information) to MATHCOUNTS in advance of the competition,
- (4) Competitors and proctors will both be required to review the competition rules and proctoring guidelines on the online competition prior to starting the test,
- (5) Competitors will be required to sign an Honor Pledge at the beginning of the competition and an Honor Pledge Certification at the end of the competition,
- (6) Proctors will be required to submit their name, relation and contact information at the beginning of the competition and sign a Proctor Certification at the end of the competition, and
- (7) Competitors will have the option to request assistance identifying a proctor.





#### **NEXT ASME-HAWAII GENERAL MEMBERSHIP MEETING**

Date: Date yet to be determined for in person meeting depending on COVID-19 status, such as current State Social Distancing proclamation relaxation, vaccine implementation, and depending if remote-virtual meetina conducted. As usual, all members, students and guests are invited and encouraged to attend our meetings.

#### **ASME PRIVACY POLICY**

ASME members and affiliates may have noticed that the March 2021 Wiliki was not sent out via the usual ASME-HI website/webmaster email notification. We were informed that direct email to members would be a violation of the Society's privacy policy as we are not to be in possession of member's contact information. This includes emailing the student section and its advisors.

Clarifications from ASME are sought and a meeting to discuss future communication options is to be held on Thursday, March 11, 2021. Clarifications will include: 1) Must all emails be sent "blind copied" only and only to members that have provided written consent. This specifically pertains to the distribution of documents as the ASME Group Mass Email Console (GMEC) does not allow attachments, 2) If you are considered as "friends" or "colleagues" and we mutually, but informally consent to the sharing of personal information (email address & phone numbers) with one another or others (if multiple people are on the email thread), is ASME Hawaii now allowed to email directly or must written consent still be provided under the presumption that any communication from or regarding ASME Hawaii topics are considered as "official business", 3) If you are not an ASME member or have not opted-in to receive section emails, the understanding is that no ASME Hawaii event notifications can be sent to you, and 4) How can ASME perform volunteer recruitment for the Montgomery Competition, MATHCOUNTS Competition, or other volunteer events that are not ASME events when the GMEC does not allow for its use for non-ASME events?

These are some examples of the Privacy Policy questions we are seeking answers to.

The Wiliki will still be posted on our Hawaii Section website, http://www.asme-hi.com/ so please continue to check for the latest edition every month. We unfortunately will not be able to notify you when the latest Wiliki issue has been posted as we have always done in the

past. We have attempted to use the ASME GMEC system to send out the March Wiliki, but are uncertain if we will be able to utilize this notification service as the Wiliki is not an ASME publication.

#### Hawaiian Electric employees win EPRI 2020 Technology Transfer Awards for innovation

Leaders recognized for research, results to advance clean energy

Seven Hawaiian Electric employees have been selected to receive the prestigious Electric Power Research Institute's (EPRI) 2020 Technology Transfer Awards in the Power Delivery & Utilization and Generation Technology sectors. The honor recognizes their leadership and innovation on collaborative research and technology projects that produced significant results.

"These awards are ultimately about results that provide meaningful benefits to the energy industry and the public, while helping make electricity more reliable, efficient, safe, affordable, and environmentally responsible," said Colton Ching, Hawaiian Electric senior vice president of planning and technology. "We couldn't be prouder of our employees and their exceptional contributions to advancing clean energy technologies and initiatives. winners and awards are introduced below.



Henry Lee, director of system operation, Troy **Uyehara**, superintendent of operating planning, and Michelle Sakata, operations engineer, for **Advanced Tools and Methods for Integrating** Renewables and DER. Lee, Uyehara, Sakata, and the System Operation team applied and tested EPRI tools to more efficiently integrate renewable and distributed energy resources on to the electric grid while maintaining reliability of Hawaiian Electric's generation supply.

Jimmy Yao, manager of electrification of transportation, for Electric Vehicle and Infrastructure Modeling for Deployment Programs. Yao was part of a collaborative team of eight utilities from 13 states that investigated incentives - such as free parking, HOV lane access and green electricity - for advancing future electric vehicle adoption across different customer demographics and segments.

**Alan Hirayama**, principle distribution planning engineer, and Alan Lee, senior distribution planning engineer, for **Probabilistic** Hosting Capability. The duo incorporated time-based probabilistic analysis capability for the growth of distributed energy resources across Hawaiian Electric's five-island service territory.

Karin Kimura. director of environmental division, for Accurate Assessment of NO2 (Nitrogen dioxide) and NOx (Nitrogen oxide) at Fossil Fuel Power Plants. Kimura's research/analysis improved understanding of in-stack ratios of NO2 and NOX to better assist generating units in meeting air quality standards and achieving permitting of the units.

EPRI is an independent nonprofit that conducts research, development demonstration projects for the benefit of the public in the U.S. and internationally. Membership is comprised of more than 1,000 organizations worldwide including electric utilities, business, government agencies, regulators and public or private entities involved in some aspect of the generation, delivery or use of electricity. The annual EPRI Technology Transfer Awards spotlight the value of collaborative research to the electricity sector and customers, and recognize the leaders and innovators who have applied EPRI research to produce significant results.

As a nationwide policy, a minimum of 4 competitors from each chapter advance to the Chapter Invitational. If a competitor was the top score from their school but not within the 20%, then that competitor advanced.

#### **CHAPTER INVITATIONAL RESULTS-HAWAII** FEBRUARY 25, 2021

Moving on to the State Competition on March 25, 2021, Thursday at 2:00 pm, are 23 Hawaii mathletes (Top five scores from each chapter, plus the next ten scores from the rest of the state). Tables 2 to 5 show the advancing competitors to the State Competition.

Raytheon 2021 Technologies MATHCOUNTS National Competition is scheduled for May 8-11, 2021, previously as an in-person competition; however, it will also be online using the AoPS Contest Platform.

Nhut Pham of the Hawaii Society of Professional Engineers (HSPE) coordinates MATHCOUNTS activities for Hawaii. Under these different COVID-19 conditions he communicates with coaches, parents and competitors encouraging them to participate passing on information, dates, reminders and results.
